O R D E R

A First Appeal dated 22.10.2024 preferred by Sh. Sushil Thakur R/o T-351/5. GF, Baljeet Nagar, New Delhi-110008 has been received in this office on 22.10.2024, under Right to Information Act-2005.

The appellant had moved a RTI Application on 20.08.2024, which was received in the office of PIO/SWD on 22.08.2024 and reply was provided to applicant by PIO/SWD vide his office letter No. 6644 (ID-1500)/RTI Cell/SWD dated 19.09.2024, under Right to Information Act-2005.

Aggrieved with the information provided by the PIO/SWD, the appellant filed this appeal stating therein that the PIO not provided relevant information.

DECISION

The undersigned has carefully gone through the contents of the appeal as well as RTI application filed by the appellant and the information provided to the appellant by the PIO/SWD vide his office letter No. 6644 (ID-1500)/RTI Cell/SWD dated 19.09.2024 and relevant/available record of file, it is found that the PIO/SWD has obtained the consent of the complainant under provision section 11 of RTI Act, 2005 as to whether the copy of her complaint be provided to the appellant/third party or otherwise but in turn she has refused to provide it. As such the PIO/SWD has declined to provide the sought information being third party information which has been exempted u/s 11 of RTI Act-2005. The undersigned found no reason to interfere in the reply of the PIO/SWD. Therefore, the reply of PIO/SWD is upheld.

The appeal disposed off with the above discussion and directive. Aggrieved can file appeal against this order with the Central information Commission, Bhawan Baba Gangnath Marg Munirka, New Delhi 110067 within ninety days from the date of receipt of the order under section 19(3) of the Right to Information Act-2005.
